

INFORMATION ON THE PROCESSING OF THE PERSONAL DATA FOR THE PURPOSE OF COMPETITION ORGANIZATION

Your Data Controller is Comtegra S.A. with registered office in Warsaw, ul. Puławska 474, 02-884 Warsaw, Poland (hereinafter referred to as: Company, Comtegra).

For what purpose and on what basis Comtegra will process personal data?

Your personal data will be processed for the purposes of:

- a) enabling participation in the competition – pursuant to Article 6(1)a GDPR, i.e. your consent; consent is voluntary and may be withdrawn at any time by sending an e-mail to the address: marketing@comtegra.pl; withdrawal of consent does not affect the lawfulness of the processing which was carried out on the basis of consent before its withdrawal;
- b) fulfillment of the legal obligations incumbent on the data controller related to tax settlements (regarding awarding prizes) - pursuant to Article 6(1)c GDPR in connection with the provisions of the Accounting Act;
- c) conducting direct marketing by sending commercial information about own products and services and invitations to events organized by Comtegra - pursuant to Article 6(1)f GDPR; the legitimate interest of the data controller is to promote own services and products;
- d) sending commercial information by electronic means in accordance with Article 10(2) of the Act of 18 July 2002 on the provision of electronic services – if consent is given;
- e) use of telecommunications terminal equipment and automatic calling systems for the purposes of direct marketing in accordance with Article 172 of the Act of 16 July 2004 - Telecommunications Law - if consent is given;
- f) marketing of products and services offered by Comtegra's commercial partners - pursuant to Article 6(1)a GDPR, i.e. your consent.

Personal data of competition winners and prize recipients may be transferred to the prize funders in order to meet the formal requirements related to receiving the prizes. Comtegra may also transfer your personal data to other entities entrusted with the processing of personal data in the name and on behalf of Comtegra. In addition, Comtegra will share your personal data with other recipients, including public authorities and entities performing public tasks or acting on behalf of public authorities, provided such obligation arises from the provisions of law.

Your data will not be transferred to third countries or international organizations.

For what period of time will Comtegra process the data?

- to the extent indicated in point a), d), e) and f) your data will be processed until the consent to processing is withdrawn,
- to the extent indicated in point b) your data will be processed in accordance with the requirements of the Accounting Act - for a period of 6 years from the end of the competition;
- to the extent indicated in point c) your data will be processed until you object to the processing.

What are the rights of the data subject?

You have the right to:

- access your personal data and to receive copies of personal data being processed;
- rectify your inaccurate personal data;
- claim data erasure (right to be forgotten) in cases referred to in Article 17 GDPR;
- obtain restriction of personal data processing in cases referred to in Article 18 GDPR;
- object to data processing in cases referred to in Article 21 GDPR;
- transfer the data provided, processed in an automated manner.

If you believe that your personal data is being processed unlawfully you may lodge a complaint with the supervisory authority - Personal Data Protection Office, ul. Stawki 2, Warsaw.
